A303 / A358 Traffic Surveys

Highways England (HE) has notified SCC of their intention to carry out traffic surveys in Somerset in the form of roadside interviews between 13 October and 20 October. The dates and locations of the surveys are –

A303 west of Parish Hill	Wednesday 14 October	Westbound
A303 west of Horton Cross	Thursday 15 October	Eastbound
A303 west of Horton Cross	Thursday 15 October	Westbound
A358 East of West Hatch Lane	Tuesday 20 October	Eastbound
A358 west West Hatch Lane	Tuesday 20 October	Westbound

The purpose of the surveys is to collect accurate information about travel patterns along the routes; this will be used to develop a mathematical model of the traffic. HE will then be able to test and compare the various options they are developing for improving the routes. This information will be used to progress the Development Consent Order and allow the design and consultation of the road improvement schemes to take place in the next two to three years.

SCC worked with other authorities in the South West to lobby government to deliver the road improvements on the A303 and A358 for the benefit of the region; these surveys are an essential part of delivering the infrastructure. It is not in SCC's interest to encourage people to avoid the surveys as this can skew the data that is collected which in turn may have an impact on the design of the scheme.

Roadside interviews are a form of survey where vehicles are required (by police) to stop in a survey bay. The survey team then carries out a short interview with the driver before the police allow the vehicle to return to the road. It is not mandatory for the driver to answer the questions but they must follow the police instructions.

The nature of this survey method means that it can be disruptive to the traffic and frequently causes complaints from residents who have been delayed on their journeys. It is understandable that the impact of these surveys will frustrate some road users however they are the most accurate way of obtaining the data needed to progress the road improvement schemes that will be of great benefit to Somerset in the future.
